1. MAIN DUTIES AND RESPONSABILITIES

Under the direct supervision of the Project Officer and the Program Technical Coordinator the Health Officer will be responsible for:

- Assisting the Project Officer and Program Technical Coordinator in planning and coordinating program activities;
- Monitoring and Evaluating planned activities;
- Managing data collection;
- Providing Technical assistance to the State Ministry of Health and Local Health Authorities;
- Supervising NGOs program activities implementation;
- Ensuring liaison with all the relevant health and political authorities and stakeholders of the State and target Localities;
- Ensuring compliance with program procedure;
- Writing activities report;
- Translating relevant program documentations;
- Perform other tasks required by the Project Officer and the Program Technical Coordinator.

2 TECHNICAL/ACADEMIC REQUIREMENTS

- Degree in health care or similar areas;
- Good knowledge of English spoken and written
- Mother-tongue Arabic or fluent (C1)
- Good knowledge of the office package software (**excel, word, power point**).
