7. Contract description

The aim of the contract is to strengthen the diagnostic capabilities of the public healthcare facilities in Gedaref and Port Sudan, providing in a "turn-key project" each a Digital Mammography unit that should be used for a wide variety of chest diagnostic procedures.

The Digital Mammograph should be good brand, new, complete with technical console and software package.

All equipment, peripheral devices, application software and related services (transport, delivery, installation, training and maintenance) must be provided.

CONDITIONS OF PARTICIPATION

10. Eligibility

Participation is open to all natural persons who are nationals of and legal persons (participating either individually or in a grouping – consortium - of tenderers) which are effectively established in Sudan and/or in neighboring DAC countries and/or in OCSE members' countries, unless if they are in any of the situations mentioned in Sections 2.4. (EU restrictive measures), 2.6.10.1. (exclusion criteria) or 2.6.10.1.1. (rejection from a procedure) of the **Practical guide**. Should they do so, their tender will be considered unsuitable or irregular respectively.

11. Number of tenders

No more than one tender can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as leader or member of a consortium submitting a tender). In the event that a natural or legal person submits more than one tender, all tenders in which that person has participated will be excluded.

12. Grounds for exclusion

As part of the tender, tenderers must submit a signed declaration, included in the tender form, to the effect that they are not in any of the exclusion situations listed in Section 2.6.10.1. of the practical guide.

Tenderer included in the lists of EU restrictive measures (see Section 2.4. of the PRAG) at the moment of the award decision cannot be awarded the contract.

13. Sub-contracting

Subcontracting is allowed. Subcontract is allowed up to an amount of 30% of the total contract amount.

SELECTION AND AWARD CRITERIA

16. Selection criteria

The following selection criteria will be applied to the tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole. if not specified otherwise. The selection criteria will not be applied to natural persons and single-member companies when they are sub-contractors.

1) Economic and financial capacity of the tenderer (based on item 3 of the tender form). In case of tenderer being a public body, equivalent information should be provided. The reference period which will be taken into account will be the last three years for which accounts have been closed.

The selection criteria for each tenderer are as follows:

- the total turnover of the candidates/bidders in the last three years in the same field of
 the bid must be at least equivalent to the maximum budget of the contract; enterprises
 that have been established for less than three years may prove their economic and
 financial standing with any document which the contracting authority may deem
 appropriate.
- 2) Professional capacity of the tenderer (based on items 4 of the tender form).

The reference period which will be taken into account will be the last three years from submission deadline.

The selection criteria for each tenderer are as follows:

- has sufficient ongoing staff resources and expertise to be able to handle the proposed contract
- has a professional certificate appropriate to this contract;
- <u>**Technical capacity of tenderer**</u> (based on items 5 and 6 of the tender form). The reference period which will be taken into account will be the last five years from submission deadline.

The selection criteria for each tenderer are as follows:

the tenderer must have supplied at least one similar project in the last five years.
 Candidates/bidders shall provide a full record of the activities performed during the
 last five years; enterprises that have been established for less than five years may
 prove their professional and technical capacity with any document, which the
 contracting authority may deem appropriate.

This means that the project the tenderer refers to could have been started or completed at any time during the indicated period, but it does not necessarily have to be started and completed during that period, nor implemented during the entire period. Tenderers are allowed to refer either to projects completed within the reference period (although started earlier) or to projects not yet completed. In the first case the project will be considered in its whole if proper evidence of performance is provided (statement or certificate from the entity which awarded the contract, proof of final payment for services). In case of projects still on-going only the portion satisfactorily completed during the reference period although started earlier will be taken into consideration. This portion will have to be supported by documentary evidence (similarly to projects completed) also detailing its value. If a tenderer has implemented the project in a consortium, the percentage that the tenderer has successfully completed must be clear from the documentary evidence, together with a description of the nature of the services provided if the selection criteria relating to the pertinence of the experience have been used.

Previous experience which would have led to breach of contract and termination by a contracting authority shall not be used as reference.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links, which it has with them. It must in that case prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing a commitment on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility - notably that of nationality - and must comply with the selection criteria for which the economic operator relies on them. With regard to technical and professional criteria, an economic operator may only rely on the capacities of other entities where the latter will perform the works or services for which these capacities are required. With regard to economic and financial criteria, the entities upon whose capacity the tenderer relies, become jointly and severally liable for the performance of the contract.

18. Deadline for receipt of tenders

The deadline for receipt of tenders is specified in point 8 of the instruction to tenderers.

19. Tender format and details to be provided

Tenders must be submitted using the standard tender form for local open procedures, the format and instructions of which must be strictly observed. The tender form is available from this Tender Dossier.

The tender must be accompanied by a declaration of honour on exclusion and selection criteria using the template available from this Tender Dossier.

Any additional documentation (brochure, letter, etc.) sent with a tender will not be taken into consideration.

20. How tenders may be submitted

Tenders must be submitted in English exclusively to the contracting authority, using the means specified in point 8 of the instructions to tenderers.

Tenders submitted by any other means will not be considered.

By submitting a tender, tenderers accept to receive notification of the outcome of the procedure by electronic means.

21. Alteration or withdrawal of tenders

Tenderers may alter or withdraw their tenders by written notification prior to the deadline for submission of tenders. No tender may be altered after this deadline.

Any such notification of alteration or withdrawal shall be prepared and submitted in accordance with point 8 of the instructions to tenderers. The outer envelope (and the relevant inner envelope if used) must be marked 'Alteration' or 'Withdrawal' as appropriate.

22. Operational language

All written communications for this tender procedure and contract must be in English.

23. Legal basis

The law applicable to this contract, including the tender procedures, and its execution is the law of the country of the Contracting Authority, which is Italy, supplemented as appropriate by the Sudanese law.

Any dispute arising out of or in connection with the award of the contract, the contract and its execution shall be referred to the courts of Italy, or Sudan as appropriate according to the applicable Italian and Sudanese law.
