1. MAIN DUTIES AND RESPONSABILITIES

The candidate is requested to work under the supervision of the Program Technical Coordinator, showing excellent comminication skills, total reliability, punctuality, and ability to learn detailed procedures and adhere to them.

- Drive fleet vehicles for the transportation of authorized personnel and the delivery/collection of mail, documents, cargo, pouches and other items.
