The contracting Authority requests the presentation of the taxes payment regularity (DURC).

The contract will be sent to you for signature if you provide the above requested evidence documents within 15 calendar days following receipt of this notification of award. Note that the contracting authority may not be in a position to honor the contract if the required documents/information is not submitted within the above time limit or if they do not meet the requirements set out above. The contract must be signed by the two parties by with 30 days at the latest.

Please take note of the possibility – as described in the instructions to tenderers – that the tender procedure may – under certain circumstances – be cancelled by the contracting authority. In no circumstances will the contracting authority be liable for damages, whatever their nature (in particular damages for loss of profits) or relationship to the cancellation of a tender, even if the contracting authority has been informed of the possibility of damage.
