**4. Legal basis, eligibility.**

Participation is open to all legal persons participating either individually or in a grouping – consortium – of tenderers.

Participation is also open to all international organisations and No Profit Organisations (NGOs)

**5. Candidature**

All eligible natural and legal persons (as per item 4 above) or groupings of such persons (consortia) may participate to the tender.

A consortium may be a permanent, legally established grouping or a grouping which has been constituted informally for a specific procurement procedure. All partners of a consortium (i.e., the leader and all other partners) are jointly and severally liable to the contracting authority.

The participation to the tender of an ineligible natural or legal person will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

**6. Number of tenders**

No more than one tender can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as leader or partner of a consortium submitting a request to participate or tender). In the event that a natural or legal person submits more than one tender, all requests to tenders in which that person has participated will be excluded.

**7. Sub-contracting**

Sub-contracting is allowed.

**8. Provisional commencement of the contract**

July 2022

**9. Period of implementation of tasks**

8 (eight) Months.

**10. Language of the procedure**

All written communications for this tender procedure and contract must be in English.

**11. Additional information**

Financial data to be provided by the candidate in the tender submission form must be expressed in EURO. If applicable, where a candidate refers to amounts originally expressed in a different currency, the conversion to EURO shall be made in accordance with the Bank

of Italy exchange rate of the related month and Year.

## SELECTION CRITERIA

### 12. Selection criteria

Capacity-providing entities

An economic operator (i.e. candidate or tenderer) may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. If the economic operator relies on other entities, it must in that case prove to the contracting authority that it will have at its disposal the resources necessary for the performance of the contract by producing a commitment by those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality as the economic operator relying on them and must comply with the selection criteria for which the economic operator relies on them. **Furthermore, the data for this third entity for the relevant selection criterion should be included in a separate document.** Proof of the capacity will also have to be provided when requested by the contracting authority.

With regard to technical and professional criteria, an economic operator may only rely on the capacities of other entities where the latter will perform the tasks for which these capacities are required.

With regard to economic and financial criteria, the entities upon whose capacity the economic operator relies, become jointly and severally liable for the performance of the contract.

The following selection criteria will be applied to the tenderer to confirm tenderer capacities.

#### 1) Economic and financial capacity of the tenderer

(based on item 3 of the tender form)

The reference period which will be taken into account will be the last three financial years for which accounts have been closed.

**The average annual turnover of the tenderer must exceed the maximum budget of the contract.**

#### 2) Technical capacity of tenderer

(based on items 5 and 6 of the tender form)

The reference period which will be taken into account will be the last three years preceding the submission deadline.

**The tenderer must have provided services of similar nature during the least 3 years with a budget of at least that of this contract**
