Despite of the number of the new health centres are increasing, the deficiency in number and mix trained motivated health workers is a critical health system issue. The inequitable access to skilled and experienced health workers impacts health outcomes and increase socioeconomic disadvantages. There is an imbalance between the need for, demand for and supply of health workers in Darfur. While needs are high, underinvestment has weakened demand for health workers and resulted in insufficient numbers of health workers available for covering the needs of the region. The purpose of this contract is to increase access to skilled and experienced health workers in rural/remote/conflicts areas in North Darfur State

through an improved recruitment, development, attraction and retention plan.
