2. Access to a **new source of funding** through Revolving funds schemes for women and vulnerable people running IGAs (income-generating activities) in Red Sea State;

5. **Enhanced opportunities** to access formal micro financial lending mechanisms for women and vulnerable groups in the Red Sea State
