# The Humanitarian and Development Nexus

The armed conflict and widespread humanitarian crises and called for a **contingency plan**:

#### **ANALYSIS PHASE**

- 1) Revised Risk Assessment
- 2) Revised Needs Assessment



#### **IMPLEMENTATION PHASE**

- 3) Adjusted Strategy and Operation Protocol
- 4) Mitigation Measures
- 5) New emergency-oriented reponses



# The Humanitarian and Development Nexus

Humanitarian crises pose a formidable development challenge.

However, there is no longer **a dichotomy between humanitarian assistance and development interventions** as two distinct, sequential responses.

**Financial inclusion** is a particularly powerful tool that countries, development and humanitarian institutions can mobilize to help mitigate the devastating impact of humanitarian crises.

**R1 Action**: design of **Emergency** and **in-kind support** services for agricultural entrepreneurs.



# The Humanitarian and Development Nexus

"We must return our focus to the people at the center of these crises, moving beyond short-term, supply-driven response efforts towards **demand-driven outcomes that reduce need and vulnerability**".
